# What is a Children's Aid Society?

- CAS
- Also known as Family & Children's Services or Child & Family Services
- Established under the authority of the Child
  & Family Services Act (CFSA)
- Mandated to provide child protection services
- Non-profit
- Funded by Ministry of Children & Youth Services



#### What is a CAS?

- For children birth to 16 and their families
- To help and support children and their families
- To intervene to protect children
- To provide care for children when necessary



#### Overview of Child Protection

- •44 Children's Aid Societies and 6 Aboriginal organizations providing child protection service in Ontario
- Referrals can be made 24 hours per day 7 days per week 365 days per year
- In 2013 2014 Ontario CASs received more than 198,000 calls about child protection concerns from citizens, neighbours, health professionals, teachers, police officers, families themselves and others
- 81,469 investigations were completed, with 23,341 children/youth receiving in care services



#### Child's Status

- Service to most children is provided in the community
- Children are admitted to care because of maltreatment – abuse, neglect, abandonment
- If children are admitted to care,
  - Voluntary
    - Temporary Care Agreement (TCA)
    - Customary Care Agreement
  - Through court
    - Temporary Care & Custody (pending disposition)
    - Society Wardship (temporary wardship)
    - Crown Wardship (permanent wardship till 18)



### Types of Placements

- Children/youth in care must be in a licenced placement
- Foster Care regular, kinship, specialized, treatment, mixed modality
- Customary Care
- Group Care



### Role of the Children's Service Worker

- Carries out the role as legal guardian, on behalf of the Society, for children/youth in Society care
- Assesses, develops and implements interventions to meet the physical, mental, emotional, social and spiritual needs of each child/youth in the Society's care
- Establishes/develops a trusting relationship in order to support and facilitate the child's growth and development while in care



## Role of the Children's Service Worker

- Provides counselling to the child/youth and initiates support linkages for the child/youth with internal and community resources including schools, medical facilities, YCJA, children's mental health, immigration, etc.
- Coordinates service requirements and advocates on behalf of the child to ensure the receipt of appropriate and timely services.


